## Council Committee Votes to Keep Silver Spring Tax Dollars to Support Silver Spring

Last Thursday, the Montgomery County Council's Transportation, Infrastructure, Energy, and Environment Committee (T&E) voted unanimously to defer a recommendation in the County Executive's proposed FY15 budget that would have transferred \$1.1 million per year out of the Silver Spring Parking Lot District (PLD) into the General Fund beginning next year. Property owners in the PLDs pay higher taxes than those in the rest of the county in order to fund the enhanced maintenance and security services that are needed in the more urban areas of the county. The Executive had proposed diverting some of those taxes to pay for programs elsewhere in the county. GSSCC has consistently advocated for keeping the extra tax revenues paid by Silver Spring property owners – and by extension, their tenants – strictly as intended for programs that support Silver Spring. Thanks to Committee Chair Roger Berliner and Committee members Hans Riemer and Nancy Floreen for voting against the Executive's proposal. Thanks also to District 5 Councilmember Cherri Branson, who is not a member the committee, but who came to the meeting and did an excellent job of challenging OMB staff and Council staff on the transfer. It's important to note that subsequent to the original recommendation calling for the transfer of \$1.1 million from the PLD to the General Fund for the next 15 years, the Executive came back asking for \$1.1 million on FY15 and \$2.2 million per year for the next 8 years. GSSCC's success in getting the delay this year is important because it halted a dangerous precedent and will give us time to take a more global look at the function and structure of the PLDs, once this budget cycle is over. Full Council will take up these matters tomorrow.
